TERM AND TERMINATION OF AGREEMENT

The Operator shall provide a complete and accurate report of all the Savvy Vending Machine sales located at the facility to the Location Client. The Operator will pay the Location Client the amount due for the previous month by the 10th of the following month.

SELECTION AND PRICING
